  - > \$7,000+ project: Island Removal
  - ➤ Monthly cost for surveillance video at pool: Yes. We pay for Comcast and the camera monitoring

### 4. Management Report:

- Pools:
  - ➤ Order in for panel replacements at the front pool. Industrial grade.
  - > Skimmer replaced at front pool
  - ➤ Back pool canopy: 1 bid in, waiting on 2 others. Bid included the option for an awning and a free-standing canopy. Installation takes 2 weeks (must be permitted). If canopy is placed at the pool gate, monitors cannot see kid pool, and may block ingress and egress of pool.
- Violations:
  - ➤ Compliance Committee back on track.
  - Street by street is getting hit hard. Streets split up between Management and Committee.
  - > Ordering stake signs for "no parking on lawns"
  - Liens can be put on homes once the fine has reached \$1,000
- Financials: as of May 31st, 2019
  - > Operating: \$269,012.39
  - Union Money Market: \$87,244.92

Delinquency Balance: \$240,541.73 down \$10,411.14 from April
